Some General Guidelines:-

- In view of the importance of "social distancing" colleges shall take necessary steps to ensure that the students are given exposure to laboratory assignments / practical experiments through virtual laboratories, sharing of the recorded visuals of laboratory work and digital resources available for the purpose. The link provided by Ministry of Human Resource Development for virtual laboratories to facilitate the students of science may also be suitable for such purposes.
- 2. Every institute should develop virtual classroom and video conferencing facility and all teaching staff should be trained with the use of the technology.

Note:-

- The college shall submit the applications for issue of Eligibility Certificates in respect of Foreign Nationals before 17.11.2021. The application received after this date will not be considered.
- 2. The last date for obtaining permission from University for admission to III / V & VII semester on transfer from other colleges/Universities and readmission to III / V & VII semester is before 10.11.2021.
- 3. Prior permission must be obtained from the University for opting Additional English/Language for only eligible candidates as per Guidelines / Instruction for admission to under graduate courses Notification No:Aca.I/Guidelines/2004-05, dated: 02.09.2004.
- The Principal shall ensure to obtain permission from the University for the students who have discontinued the degree programme within the five years from the date of joining (N+2=5 years UG courses and BHM and BVA courses N+2=6 years).

- The Guidelines for completion of degree circulated vide circular No: Aca-I/UGC-Guidelines/Span Period/2017-18, dated: 13.07.2017 may be displayed on the College Notice Board.
- Regulations Governing the Choice Based Credit System (Semester Scheme) in the Undergraduate and Integrated Masters Degree Programmes in the Faculties of Arts, Science and Commerce shall be followed for the academic year 2020-21.
- Principals are requested to allot the invigilation work to the teachers of major subjects such as Commerce, Management, English, Mathematics, Economics, etc., in the beginning of the theory examination and relieve them immediately for evaluation work.
- 4. Principals are further requested to compulsorily collect the evaluation attendance certificates from all the teachers who attended evaluation work in different subjects and produce them before the Local Inquiry Committee for verification at the time of visit.
- 5. During vacation, it is mandatory for teachers to undertake theory valuation and practical examination related work assigned by the University. Otherwise disciplinary action will be initiated for dereliction of duty, in the case of University, Government, and Aided College teachers and in the case of Unaided colleges attending to the examination work is one of the conditions to continue Affiliation.
- 6. Wherever Bio-Metric attendance is implemented, the principals are requested to take permission from the Higher Authorities to waive the requirement of attendance of the teachers on the days of the examination related work in the University especially during the evaluation of answer books.
- 7. The colleges have to collect and remit the fee as prescribed by the University.
- The Principals are requested to adhere to the above schedule of Calendar of Events and follow the Rules and Regulations strictly.
